Sponsorship of Winter Village provides for free public skating and special programs that draw thousands of visitors to the Park on a daily basis.

4b (Code:) (Expenses \$ 2,285,085. including grants of \$) (Revenue \$) Park maintenance and sanitation: Uniformed sweepers pick up litter, empty trash receptacles, and clean the Park's restrooms and other facilities.

4c (Code:) (Expenses \$ 2,305,897. including grants of \$) (Revenue \$ 534,300.) Public events and outdoor reading room: Bryant Park produces and hosts more than 1000 free public events, performances and activities each year. The well attended and popular events include large productions, such as the Bryant Park Summer Film Festival and Broadway in Bryant Park, as well as, daily lunch-time and evening presentations and performances.

Bryant Park Corporation, 34th Street Partnership, Inc. and Bryant Park Management Corporation are commonly managed not-for-profit organizations, sharing senior managers and department directors. The organizations also share administrative office space and related expenses. The salaries of shared employees are allocated, based on the amount of time spent on each entity, and paid by each respective entity, under its own employer ID number. Shared expenses, such as office rent, utilities and office supplies are allocated between the companies based on the percentage of salary and space occupied by the shared employees. Allocated expenses are reconciled and reimbursed to the respective entities on a monthly basis.
