Schedule R, Part V, Line 1n: Brvant Park Corporation and 34th Street Partnership, Inc. are commonly managed not-for-profit organizations, sharing senior managers, department directors and administrative staff. The salaries of shared employees are allocated between the entities, based on time devoted to each, and paid under each of the entities' respective employer ID numbers. Allocated expenses are reconciled and reimbursed to the respective entities on a monthly basis.
